Short Term Rentals

Definition: Short-term rentals are properties that are rented for less than 30 days at a time and do not meet the definition of a bed and breakfast operation under Eagle County Land Use Regulations.

Short-term rentals are strictly prohibited within Sopris Village, including the use of online booking services for rental purposes. Online booking services include, but are not limited to, Airbnb, HomeAway, and VRBO. The Association may monitor such online services for purposes of ensuring compliance with these Rules and Regulations. Violations must be removed from these sites immediately upon notification and are subject to fines as determined by the Association Board of Directors.
