1. CALL TO ORDER

Financials/ Accounts Payable

2023 Preliminary Budget discussion

The Board discussed the third draft of the preliminary budget for 2023. The only change made was to increase the budget for Insurance to \$2,200.00, to compensate for expected increase in unknown insurance premiums.

Director Mike Meiners moved and Director Michael Kendrick seconded to approve the 2023 Preliminary Budget version 3, effective January 1, 2023. Motion Passed.

ACC Application Rule

The Board discussed imposing a new ACC rule, that would prevent homeowners from submitting ACC applications if their accounts are not current. The Board reviewed draft language and would like to add delinquent on "assessments, fees and fines." Does not include owners who are on a payment plan with the Association.

With these changes, the Board would like send the draft language to legal counsel for review.

070 Cheyenne Enforcement Discussion

The Board was notified that the ACC Application for 070 Cheyenne was denied by the ACC. The homeowner has been notified and has been sent a Notice of Violation.

Annual Meeting Prep Discussion

The Board asked Management to make sure that the meeting will have Zoom capabilities. Megan and Michael Kendrick will meet on Monday or Tuesday November 28 or 29 to test equipment for Zoom at the Eagle County Community Center. Megan will call Eagle County and see which day and what time will work best to test equipment.
